We received an application to designated Segovia Street from Alhambra to Bird Road as a local historic district. On October 7, 2013 I issued significance determinations on two properties (letters attached) 2909 and 2915 Segovia that fall within the boundaries of the district. These determinations are good for six months and the letter states that the Historical Resources staff will not require review by the Historic Preservation Board of an application is made for a demolition permit.

My question is, since I now have an application for that area to be a district, the Zoning Code says the following -

Section 3-1104A3

Whenever a determination is made by either the Director of the Historical Resources Department or the Historic Preservation Board that an application for historic designation shall proceed to public hearing as provided in this Division, no development permits shall be issued until the public hearing is held and a determination made on the subject designation in accordance with the provisions of Section 3-1104(C). In the case where an owner seeks a demolition permit, the public hearing shall be held at the next regularly scheduled meeting where notice can be provided.

Am I able to sign the demolition permit for these properties?
