RE: Legal Opinion Regarding Placement On Agenda

Date: June 2, 2014

Relating to 6801 Granada Boulevard, I have considered Items E-4 and E-5 (proposed ordinances) from the May 13, 2014 Agenda, as well as the proposed resolution approving the final plat. The two ordinances were approved on first reading with a request made by the Commission that a closer review be done of the specimen trees on the property, including how the applicant could better preserve them (and place future purchasers on notice of the duty to preserve). The Commission also expressed concerns about the setback, both in its relation to the specimen trees and the character of the neighborhood. Consistent with these instructions, the City requested an updated tree survey from the applicants containing the location and type of specimen trees, and is still awaiting that survey as of this morning. This survey would need to be reviewed by Development Services and Public Service prior to placing the ordinances on an available agenda for second reading. In addition, staff has not finalized its review yet of the final plat. Further, it is my understanding that the upcoming agenda is already very full, and this item is still not ready.

For all of these reasons, it is my opinion that this matter is not ready to be placed on the June agenda, that additional information is still required of applicant before this can proceed, and that it should be scheduled on an available future agenda in July or August (after consultation with the applicant's counsel). This would be consistent with the Commission's instructions requesting additional information, as well as within your authority as City Manager. Please confirm your approval, and I will inform the applicant's counsel.
