Date: October 3, 2014

Yes, by Code, they need only notify the City Manager's office as it is a political demonstration. It is only if a street or sidewalk needs to be closed (or they are requesting relief under the noise ordinance or something similar) that a request/permit would be reviewed. The City may impose reasonable time, place, and manner restrictions on the demonstration, and may ensure that a right-of-way is not obstructed. If they are requesting a permit, please let me know, as I can advise on First Amendment compliance (we also use Abby Corbett from Stearns Weaver on First Amendment matters if the issue becomes complex or disputed).
