RE: Legal Opinion Regarding Request For Public Records: On Controlled Choice Schools. Communications/Documents Between The City And Outside Counsel Are Exempt From Public Disclosure Under Section 119.071(1)(d) Of Florida Statues

Date: February 25, 2015

I have reviewed the request and considered Chapter 119 of the Florida Statutes, along with the Government-in-the-Sunshine Manual. It is my opinion that the request for communications/documents between the City and outside counsel are exempt from public disclosure at this time under section 119.071(1)(d) of the Florida Statutes, based on the present administrative proceeding before the School Board (which is a contested proceeding at this point), including the imminence of litigation that has been threatened against the City relating to the administrative proceeding and the controlled choice matter, as well as the imminence of litigation that may be brought by the City relating to the administrative proceeding and controlled choice matter. Outside counsel has been advising the City in relation to the administrative proceeding and in anticipation of litigation, and the City has a statutory right to protect those documents from disclosure until the matter is complete. Likewise, there are documents prepared by the City Attorney's Office, as in house counsel, that fall under the same exemption. I am asking the Assistant City Attorney to review available documents and provide ones to you that do not fall under these exemptions (for example, public or informational documents that have been provided to the Commission and that are not subject to the exemption). She will be in contact with you soon.
