









PRESERVATION OF HOME RULE & PREEMPTION OF LOCAL REGULATIONS

• Oppose legislation that would preempt local governments from legislating, regulating, or acting on matters of local concern in the interest of the health, safety, and welfare of their communities.

BERT HARRIS ACT

• Oppose further changes to the Bert J. Harris Jr. Private Property Rights Protection Act that would disadvantage local governments and limit the City's ability to quickly resolve claims.

SOVEREIGN IMMUNITY

• Oppose legislation that would increase the \$300,000 per-occurrence limit on the collectability of judgments against government entities and/or eliminate the \$200,000-per-claimant limit contained in Section 768.28, Florida Statutes.

EMERGENCY POWERS

• Support repeal of SB 2006 (2021), which amended Section 252.38, Florida Statutes, to limit the City's ability to enact and enforce local emergency orders and provides for the automatic expiration of local emergency orders.

BISCAYNE BAY

• Support legislation that prioritizes the health and protection of Biscayne Bay and allocates needed funding for the Bay's conservation.

COMMUNICATIONS SERVICES TAX AND LOCAL BUSINESS TAX PROTECTION

• Support legislation that protects general revenues collected from the communications services tax and the local business tax.

VACATION RENTALS

- Oppose legislation that would further preempt local governments from regulating vacation rentals.
- Preserve the grandfather clause in Section 509.032(7)(b), Florida Statutes, which allows local regulations adopted on or before June 1, 2011 to remain in effect.

ASSAULT WEAPON AND HIGH-CAPACITY MAGAZINES

- Support legislation that would ban the sale of semi-automatic assault weapons in the State of Florida.
- Roll back the arduous penalty provisions in Section 790.33, Florida Statutes, including but not limited to provisions related to declaratory judgments, civil fines, termination of employment, personal cause of action and the limitation on the use of public funds.
- Amend Section 790.33, Florida Statutes to allow municipalities to enact common-sense zoning regulations that encompass firearms businesses.

PRINCIPLES OF INCLUSION

• Support legislation that promotes principles of inclusion, including but not limited to, respect for the inherent dignity of individuals, non-discrimination, equality of opportunity, accessibility, equality between men and women, respect for the evolving capacities of children with disabilities, and respect for the right of children with disabilities to preserve their identities.

POLYSTYRENE AND SINGLE-USE PLASTIC BAGS

- Support the amendment of Sections 403.7033 and 500.90, Florida Statutes to eliminate preemptions of local law relating to the regulation of auxiliary containers, wrappings, disposable plastic bags, and polystyrene.
- Support legislation that would prohibit the use of single-use plastic bags and polystyrene containers statewide.
- Support Agricultural Commissioner Nikki Fried's plan for reduction of the use of polystyrene materials by grocery stores, markets, and convenience stores etc.

ZONING AUTHORITY AND BUILDING DESIGN ELEMENTS

- Oppose legislation that would preempt a local government's authority to enact zoning regulations, including regulating building design elements for one-and two-family dwellings.
- Preserve the carve out in Section 163.3202, Florida Statutes for cities with architectural review boards.

HOME-BASED BUSINESSES

- Support repeal of HB 403 (2021), which enacted broad state preemptions on the regulation of home-based businesses via Section 559.955, Florida Statutes.
- Preserve the City's ability to enforce the Americans with Disabilities Act (ADA), Florida Building Code, and Florida Fire Code as applied to home-based businesses

VIRTUAL MEETINGS

- Support legislation that would allow for the automatic suspension of in-person quorum requirements so local
 government bodies, boards, and committees can safely conduct official business during a declared public health
 emergency.
- Support legislation that would allow a member of a local government body, board, or committee, to participate in a meeting via virtual or teleconferencing technology absent an extraordinary circumstance, when a physical quorum of the board is otherwise present.

TRANSPORTATION

- Support legislation that preserves local control of transportation planning and provides for a more equitable
 transportation funding formula between municipalities and counties, including additional dedicated revenue options
 for municipal transportation infrastructure and transit projects. Support legislation that allows municipalities to
 receive transportation infrastructure grants and moneys directly from the State, bypassing distribution on a County
 level.
- Support legislation and appropriations to fully fund the Underline Project, and the Miami-Dade SMART plan.

SMALL CELL WIRELESS

- Support legislation that preserves the City's ability to exercise its home rule authority to control use of its rights-of-way for communications facilities, including small cell facilities.
- Support the City's ability to exercise authority over City-owned poles in its rights-of-way.
- Oppose legislation that would expand the preemption of home rule authority already within the Advanced Wireless Infrastructure Deployment Act.

RISK PROTECTION ORDERS

- Support legislation that preserves the City's ability to enhance public safety by restricting firearm and ammunition possession by a person who poses a significant danger to themself or others.
- Support legislation that requires persons under Risk Protection Orders to demonstrate there is no further significant danger to themself or others before a Risk Protection Order is terminated.
- Support legislation that broadens the categories of individuals who can seek Risk Protection Orders based on biological or legal relationships.

PROTECTION OF CITY'S TREE CANOPY

- Support repeal of Section 163.045, Florida Statutes which preempts the City's ability to require permits for certain tree removals on private property.
- In the alternative, amend current law to apply only to developed single-family residential property, to identify industry-appropriate standards for assessing tree risk, to clearly define "danger to persons or property", and to identify necessary documentation needed for compliance. These changes would reduce fraudulent reporting and inappropriate tree removals and better serve the Legislature's intent.

CLARIFICATION OF "BEST EFFORTS" TO SUPPORT THE ENFORCEMENT OF FEDERAL IMMIGRATION LAW

• Support the repeal of Section 908. 104, Florida Statutes or in the alternative support legislation that clarifies the term "best efforts" of a local law enforcement agency.

EXPANSION OF PACE PROGRAMS TO FINANCE SEPTIC TO SEWER CONVERSION

• Amend Section 163.08, Florida Statutes to expand the list of qualifying improvements that may be financed through Property Assessed Clean Energy (PACE) programs to include conversion from septic tanks to sewer systems and other sewage treatment improvements.

FLORIDA BUILDING CODE

- Support the creation of a statewide 30-year recertification process similar to Miami-Dade County's process that additionally requires structural engineers and electrical engineers to complete reports for threshold buildings.
- Eliminate a Homeowner's Association's (HOA) ability to waive statutory cash reserve requirements.
- Support the imposition of an affirmative notification requirement on private engineers to report life safety issues to local building officials within a defined amount of time.

REAL ESTATE

• Support legislation that would create a mandatory septic tank inspection for real estate transactions.

LOCAL OPTION FUEL TAX

• Support legislation that adds to the allowable uses for local option fuel tax proceeds.

CULTURAL ARTS

• Support legislation that promotes and funds arts & culture programs and facilities to preserve access to the cultural, educational, and economic benefits of the arts.

REDUNDANT POLES

• Amend Section 366.97, Florida Statutes to require attaching entities to remove their pole attachments from redundant poles within 180 days. Eliminate the pole owner's ability to transfer ownership of a pole to an attaching entity for failure to remove attachments.

FUNDING

Mobility Hub

The City is seeking \$975,000 in matching funds for the electric vehicle charging stations (EVC) and photovoltaic panels (PVP) on the new state-of-the-art Mobility Hub. These components are a critical part of the project and will drastically reduce vehicular carbon emissions in the City, power lighting within the Hub, and energize the activated rooftop. The Hub will be a one-of-a-kind mobility facility for public use.

Remediation of Incinerator Site

The City is seeking \$925,000 in matching funds for environmental remediation of a City facility where an incinerator building, combustion chambers, and an incinerator stack were once located. The structures were demolished in 2005, however, the site was never remediated environmentally. Among existing contaminants found in groundwater analysis are lead, dioxin, and dibenzofurans. By providing an environmentally safe facility, workers will be exercising duties in a clean air environment and groundwater contamination will be halted.

Septic to Sewer Master Plan

The City is seeking \$375,000 in matching funds to complete a comprehensive Citywide septic to sewer conversion assessment. The City estimates that over 7,400 properties are currently on septic tanks. The City recognizes that due to the potential future conditions/impacts associated with sea level rise and storm surge that a plan must be put into place to alleviate potential septic tank failures and the release of nutrients into the environment and local water bodies, including Biscayne Bay.

• Stormwater Management Master Plan

The City is seeking \$500,000 in matching funds for a Stormwater Management Masterplan. The goal of the masterplan is to assess the City's current stormwater system, parts of which have been in existence for nearly 100 years and address current flooding problems and/or areas where future challenges may occur. The plan will recommend design standards for new developments, transportation, water quality, floodplain mitigation, swales, inadequate structures, etc.

Venetian Pool Pump Repairs

The City is seeking \$500,000 in matching funds to replace the pump system at the historic Venetian Pool. This project consists of replacing existing supply and injection pumps including all associated conduits, valves and electrical work. The north supply well will be abandoned and a new supply well will be constructed. The pump control room will be retrofitted to service new equipment as well as to provide an efficient and safe operation.

FRDAP GRANTS: Toledo & Alhava Park \$200k; Blue Road Park \$200k.

Restoration of Historic Gondola Building

The City is seeking \$750k in matching funds to restore the Gondola Building, a structure listed on the Local and National Registers of Historic Places as part of the Biltmore Hotel Complex. Built in 1925 in the Mediterranean Revival style, the building was constructed to house Venetian Gondolas that would travel from the hotel through the Coral Gables Waterway to Tahiti Beach. Due to a recent collapse of three walls, this historically significant structure is now in desperate need of reconstruction and restoration. Drawings of the original structure exist to ensure it can be accurately reconstructed using original salvageable elements.

Legacy Sewer System Repairs

The City is seeking \$500k in matching funds to pay for ongoing repairs to its legacy sewer system. This project addresses sewer system defects identified in the Sanitary Sewer Evaluation Survey (SSES) and reduces inflow and infiltration in identified basins. The project will have citywide benefits and includes repairing, rehabilitating, and lining segments of deteriorated sewer lines.
